KIC ROLLiant™ LIMITED WARRANTY
TO FILE A WARRANTY CLAIM, CALL (800) 869-2275 ext. 1

KIC LLC (KIC), (Seller) hereby warrants that, during the warranty period, the KIC extended cone hub assembly system (ROLLiant™) will be free from defects in materials and workmanship. This limited warranty is extended only to the original purchaser who places the ROLLiant into service, and not to any subsequent owner or transferee of the product. These warranty periods are effective from the date of assembly indicated on the hubs. As a condition of eligibility for the ROLLiant extended warranty program, the Customer must provide specific data (full name of registered owner, mailing address, country of registration, phone number, email address, VIN, in-service date), no later than 30 days after the vehicle is put into service by the first owner. The warranty is void if users do not follow the most current version of the service and maintenance requirements. If necessary due to malfunction, components that are serviceable without removing the hub such as the hubcap and gasket or drive-axle gasket can be replaced per the instructions in the service manual. If the hub must be removed for service, prior approval from KIC is required or the warranty will be voided. All scheduled maintenance related to hub units lubricated with semi-fluid grease or oil must be performed in accordance with the maintenance manual procedure.

The sole and exclusive remedy for breach of this limited warranty shall be repair or replacement of the defective product or part. This warranty sets forth and describes Buyer's exclusive remedy and sets forth Seller's entire liability to Buyer. This warranty is limited to ROLLiant wheel hub assemblies that fail in normal use and service because of defects in material or workmanship caused by Seller. With respect to any defective product, during the warranty period, KIC will, in its sole discretion: (a) repair or replace the defective ROLLiant system (or defective component thereof) free of charge, or (b) refund the purchase price of the ROLLiant system or its components. Under no circumstances may KIC's liability exceed the purchase price of the product. This limited warranty shall not cover any collateral damage including but not limited to brake shoes or pads, drums, rotors, axles, nuts, etc., nor will it include the cost of downtime on the equipment, labor, roadside assistance, towing or loss of freight.

The ROLLiant limited warranty shall only apply if a KIC-approved lubricant is used.

This limited warranty is only valid for OEM installed, unmodified, ROLLiant wheel hub assemblies and does not apply to aftermarket products. Additionally, this limited warranty applies only to products that fail in normal use or service and shall not cover any damage to a ROLLiant system resulting from (1) Removal of the hub to service other systems or components without prior KIC approval; (2) Tampering with the spindle nut; (3) Abuse, improper installation or adjustment, repair or modification, including improper wheel nut torque; (4) Overloading; (5) Damage resulting from the vehicle being involved in an accident or natural disaster; (6) Failure to perform proper maintenance, or to retain maintenance records. (7) Any failure attributable to other equipment

including but not limited to one or more components of a tire inflation system, hub pressurization or contamination. Refer to ROLLiant maintenance manual for all component replacement procedures. Lubricants are excluded from coverage of this warranty.

The warranty claim is to be forwarded to the Warranty Department at warrantyadmin@accuridecorp.com for warranty consideration. Seller will not accept the return of the various components of the ROLLiant hub, without Seller's prior authorization. i.e. Seller must be notified of claim prior to any work on the hub system. No expenses incurred will be allowed under this warranty without Seller's prior authorization. Seller has the option to authorize the return of any ROLLiant hub or components freight prepaid for inspection, verification, and disposition of material by Seller. Buyer will be reimbursed for freight costs if the product is deemed warrantable. Any controversy or claim that customer may wish to bring that is arising out of or related to this limited warranty or breach hereof must be commenced in writing within 30 days of notification or warrantable status or shall be deemed to be waived.

Seller's liability to Buyer, or anyone claiming through or on behalf of Buyer, with respect to any claim or loss arising out of the use of ROLLiant hubs or components subject to this warranty, or alleged to have resulted from actual act or omission of Seller, whether negligent or otherwise, and whether in tort, contract or otherwise, including failure to deliver, delay in delivery, or breach of warranty, shall be limited to an amount equal to the original sale price of the component(s).

EXCEPT FOR THE LIMITED WARRANTY SET FORTH ABOVE, KIC MAKES NO WARRANTY WHATSOEVER WITH RESPECT TO THE ROLLiant PRODUCT, INCLUDING ANY (A) WARRANTY OF MERCHANTABILITY, OR (B) WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE, WHETHER EXPRESS OR IMPLIED BY LAW, COURSE OF DEALING, OR OTHERWISE.

THE REMEDIES DESCRIBED ABOVE ARE THE SOLE AND EXCLUSIVE REMEDIES AVAILABLE IN CONNECTION WITH ANY DEFECT IN KIC'S PRODUCT, OR FOR BREACH OF THIS LIMITED WARRANTY. UNDER NO CIRCUMSTANCES SHALL KIC BE LIABLE, FOR ANY CONSEQUENTIAL, INCIDENTAL, SPECIAL OR PUNITIVE DAMAGES OR LOSSES.
