

ONLINE PRIVACY AND COOKIE POLICY

1. Scope

This website is operated by Accuride Wheels Bilecik Jant Sanayi A.Ş. ("Company").

This Online Privacy and Cookie Policy explains how we protect your privacy when you visit this website, what is the "Personal Data" we collect from our website, what kind of information we collect and monitor while viewing our website, how this information is used and with whom it is shared.

"Personal Data" is the information that personally identifies you, alone or in combination with other data. Examples of Personal Data include your name, contact information, job applications, information you provide when creating an account or your personal profile on our website, information about the pages you view and the paths you follow using our website.

2. Legal Grounds for the Use of Your Personal Data

By accessing or using this website, you consent to the collection, use and sharing of your Personal Data set forth in this Online Privacy and Cookie Policy.

IF YOU DO NOT CONSENT TO THE COLLECTION, USE AND SHARING OF YOUR PERSONAL DATA AS SET FORTH IN THIS PRIVACY POLICY, PLEASE EXIT AND DO NOT USE THIS SITE.

WHERE YOU HAVE RIGHTS UNDER RELATED LEGISLATION, YOU CAN RETURN YOUR CONSENT AT ANY TIME BY CONTACTING US. WE WOULD LIKE TO REMEMBER THAT WE CAN COLLECT, USE AND SHARE ALL OR SOME OF YOUR PERSONAL DATA, EVEN WHEN YOU WITHDRAW YOUR CONSENT.

We may collect, use and share your Personal Data when necessary for the performance of the contract with you or for our legitimate interests in working, protecting and developing our business.

3. Personal Data Collected

The Personal Data we collect is Personal Data that you knowingly provide (using your mouse or keyboard) while using our website. The data we collect may vary depending on the purpose of using our website. For example, if you sign up to receive email communications from our Company, we collect your email address and related information you provide. If you use the "Contact Us" feature to contact us, we collect the data you provide in the "Contact Us" form.

In general, our website distinguishes between data we need to provide you with a particular product or service or to fulfill a request ("required fields"), and data that is optional, although

useful, about that product, service or request. We would like to remind you that if you do not provide us with the said data by filling in the mandatory fields, we will not be able to provide you with the relevant product or service or fulfill your request.

From time to time, we may supplement the data you provide to us with data we obtain from other sources (for example, information about verifying your address, information about your zip code, or information about your business). We may also supplement the data you give us with data we collect from you through other channels. For example, if you are a customer of our Company, we may supplement the information you provide online with the data you provide in other business contacts you have with our Company. The data we collect includes data that your web browser automatically sends to us. This data usually includes your IP address, the identity of your internet service provider, the name and version of your operating system, the name and version of your browser, the date/time of your visit and the pages you visit. An "IP address" is a unique number that is automatically assigned to your computer when you connect to the Internet. It is used to determine the "location" of your computer in cyberspace so that the information you want can be provided to you. If you are using a dial-up connection or a connection that assigns dynamic IP addresses, a new IP Address is assigned to your computer each time you connect to the Internet. However, if your computer is permanently connected to the Internet with a static IP address, the IP address assigned to your computer will usually be the same every time you use your computer. Even though your IP address does not identify your name, we consider it Personal Data.

When you respond to an electronic communication from us (for example, by opening an email, downloading an image, or clicking a link in an electronic newsletter), your browser informs us about the action you took (or the person using your email address). We use this data to improve our marketing strategy. We also review our server logs, which contain visitors' IP addresses, for security and fraud prevention purposes. If we suspect criminal activity, we will share our server logs and Personal Data we collect from the website with agencies that will investigate and identify the criminals.

A small file sent by the website, stored on the user's computer, and allowing the website to remember information and preferences about the user, is called a cookie. We use "cookies" and other web technologies in a number of ways. For example, we may use these technologies to:

- Collecting information about how visitors use our website (which pages they visit, what links they use and how long they stay on each page);
- To support features and functionality on our website (for example, to save you the trouble of repeatedly entering information in our database or to request settings you have created on previous visits to our website);
- To personalize your experience while using our website, and
- Measuring the success of our web or email ads.

4. Categories of cookies we use

The Cookies we use on our website can be divided into two categories. Cookie "session cookies" that are allocated to your computer during your visit to our website and are automatically removed from your computer when you close your browser.

"Persistent cookies" that expire after a reasonable period of time or when deleted by the user.

Some of these uses may include "third party cookies"; therefore, it is set by software used by third parties to perform operations such as statistical analysis of page usage, page interactions and paths used on the site or to serve internet advertisements using an online advertising supplier. Third-party cookies may collect information about your online activities on different websites you visit over time and after our website.

Generally, information collected using these web technologies does not identify you by name. However, if you have created a user ID (for example, by registering to use a password protected area on one of our websites), we combine information we collect using web technologies with other personally identifiable information.

If you do not want to receive cookies, you can set your browser to refuse cookies or to warn you when a cookie file is requested to be placed on your computer. If you wish, you can delete our cookies as soon as you leave a Site. Although it is not necessary for you to accept our cookies when you visit our website, you cannot benefit from all the features and functions of our website when you set your browser to reject them.

5. Changes to this Privacy Policy

As we add new features and functionality to our website, we may need to update or make changes to this Online Privacy and Cookie Policy. We reserve the right to do this at any time and without notice by posting the corrected version of our website. These changes will take effect from the date we publish the corrected version of our website. In addition, they will only apply to Personal Data we collect after we publish the corrected version. When you use our website after such changes, you are deemed to have accepted the terms of the revised Online

Privacy and Cookie Policy. Therefore, it is very important that you review this Online Privacy and Cookie Policy on a regular basis.

When we make changes to this Online Privacy and Cookie Policy, we will place a notice at the top of the Online Privacy and Cookie Policy for at least 30 days from the new effective date so that you can easily understand that the Online Privacy and Cookie Policy has changed since your last visit. 6. About Your Uses Requiring Special Consent

There are no password protected parts of our website.

When you sign up to use a feature or password protected area, you may be asked to agree to certain special terms governing your use of them. In some cases, you will be asked for your explicit consent for special conditions, such as ticking a box or clicking a "I agree" button. If one of the terms you click on is different from the terms of this Online Privacy and Cookie Policy, the click terms will be counted as an addition to or a correction to the terms of this Online Privacy and Cookie Policy, only on matters regulated by the terms you clicked on.

7. How Does Our Company Use Your Personal Data?

Generally, we use the Personal Data we collect from our site to:

- provide the product, information and services you request;
- security; , eg. fraud prevention;
- provide you with appropriate customer service;
- provide you with a personalized experience while using our website;
- to display personalized advertisements to you when you visit our website;
- to communicate with you to let you know about special offers and other information that we think will be of interest to you;
- to send you information and notifications regarding your use of our website;
- invite you to take part in surveys and give your feedback;
- better understanding of your needs and interests;
- improve the content, functionality and use of our website;
- improve our products and services;

- improve our marketing and promotional strategies;
- to achieve other purposes described in this Online Privacy and Cookie Policy or other agreements between you and our Company.

8. Sharing Your Personal Data

We may share Personal Data we collect from our website as described below:

- We share your Personal Data with Service Provider companies and organizations that provide services on our behalf (for example, providing us with website support services).
- We share your Personal Data with the units within the Company for the purposes specified in this Online Privacy and Cookie Policy, if "need to know".
- The Company may decide, for strategic or other reasons, to sell, buy, merge or otherwise reorganize one or more of its businesses. In such a case, it may be necessary to share your Personal Data with the purchaser as part of business transactions.
- We may share this information when we think it is necessary to share your Personal Data in order to comply with the law or a court order. Also, ensuring that a possible crime (for example, fraud or identity theft) is prevented and investigated; enforce our online terms of use or the terms of other agreements; or to protect our rights, property or the rights, property or safety of our users/others.
- We reserve the right to share your Personal Data for the purposes specified in this Online Privacy and Cookie Policy or as specified in your preference.

9. Your preferences

In some cases, we give you various choices about how we collect, use and share your Personal Data. In such a case, we may ask you to specify the options you want when collecting your Personal Data. If you have created an account or personal profile on our website, you can always update or correct some or all of your privacy options by changing the settings on your account settings or profile page.

If you have created an account or personal profile on our website, you can access and update some or all of your Personal Data in your account settings or profile page. But in most cases you will need our help. If you wish to access, update or correct your Personal Data, please contact us. We will respond to you in a reasonable time and within the time limits of applicable law. We may ask you for additional information to verify your identity. In most cases, we will allow you to access, correct or delete any inaccurate information you find. Sometimes, however, we may limit or refuse your request if permitted or required by applicable law, or if we are unable to verify your identity.

10. Your Rights

You have the below rights for your Personal Data;

- a) learn whether it has been processed or not,
- b) request information if processed,
- c) learn the purpose of processing and whether it is used in accordance with its purpose,
- d) to know the third parties to whom it is transferred at home/abroad,
- e) request correction if it is incomplete / incorrectly processed,
- f) request deletion / destruction under certain conditions,
- g) request notification of the transactions made in accordance with subparagraphs (d) and (e) above, to the third parties to whom it has been transferred,
- h) object to the emergence of a result against you due to the analysis exclusively by automated systems,
- i) demand the compensation of the damage in case you suffer damage due to unlawful processing.

11. How Long Do We Keep Your Information?

We may keep your Personal Data for commercial purposes as long as necessary, and specifically to protect our Company in the event of a legal dispute. At the end of this period, your Personal Data will be deleted and in some cases anonymized. If you subsequently withdraw your consent and we have no other legal basis to process your Personal Data, we will delete your Personal Data.

12. Security

While we take commercially reasonable measures to protect the confidentiality, integrity and security of your Personal Data, we cannot make any guarantees regarding the security of such Personal Data. Therefore, we recommend that users take every precaution to protect their Personal Data while using the internet.

13. Third Party Websites

Our website may contain links to websites operated by other companies, including websites operated by our third-party service providers and third parties with which we have no interest. This Online Privacy and Cookie Policy does not apply to Personal Data collected from such other websites. When you access third-party websites using a link on our website, please review the privacy statement posted on that site.

14. Children's Privacy

Our website is not intended for children under the age of 13. Except as permitted under the relevant legislation, we do not knowingly use our website to collect Personal Data from or market to children under the age of 13 or the relevant minimum age under applicable local regulatory requirements.

15. Overseas Data Transfer

Our Company is an organization that trades with many countries and processes your Personal Data for the purposes specified in the Online Privacy and Cookie Policy [may transfer outside national borders]. Our head office is within the borders of the Republic of Turkey. Our web servers and databases are located in Turkey [or [•]] [and our staff in other countries (or staff of our service providers) may access information on these servers and databases if "need to know". Different countries have different legislation and terms regarding privacy policy, the level of protection may be different in these countries.] However, no matter where your Personal Data is collected, used, stored and transferred, what is collected from our website is subject to this Online Privacy and Cookie Policy and your preferences.
